Unless defined below, capitalized terms used in this announcement shall have the same meanings ascribed to them as in the Company's announcements dated 29 June 2016, 24 August 2016 and 8 September 2016 (the "**Announcements**").

- 1. The Board of Directors (the "**Board**") of UG Healthcare Corporation Limited (the "**Company**") wishes to announce that the Share Transfer Books and the Register of Members of the Company had closed at 5.00 p.m. on 1 November 2016 for the purpose of determining the Shareholders entitlements to the Final Dividend.
- 2. Further to the Announcements, the Board wishes to announce that the issue price at which each New Share is to be issued ("**Issue Price**") credited as fully paid, is S\$0.2637 for each New Share.

The Issue Price represents a discount of approximately 10% to the average of the last dealt prices of a Share on which the Shares were traded on Catalist for each of the Market Days during the price determination period between 28 October 2016 and 1 November 2016 (both dates inclusive) (being the period commencing on the day on which the Shares are first quoted ex-dividend on the SGX-ST and ending on the Books Closure Date).

- 3. Fractional entitlements to new Shares under the Scheme will be rounded down to the nearest whole number in lieu of such fractional entitlements.
- 4. The Notices of Election will be dispatched to the Entitled Shareholders on 11 November 2016.
- 5. The Final Dividend will be paid on 15 December 2016. Entitled Shareholders who elect not to participate in the Scheme will receive the Final Dividend in Cash.
